PROPOSAL

As per reference (1) cited above, The Commission, Department of AYUSH, Bangalore has stated that KLE Deemed University's KLE Homoeopathic Medical College and Hospital, JNMC Campus, Nehru Nagar Belagavi has obtained a No-Objection Certificate from the Government of Karnataka for starting a new B.H.M.S Degree Course for the academic year 2017-18 with an intake of 100 students. On the basis of the said No-Objection Certificate, the said college has submitted to the Government of India for grant of permission. Ministry of AYUSH, Government of India has given permission to start the said course subject to certain terms and conditions. Hence the Commissioner has requested the Government of Karnataka to issue an Order in this regard as applicable to the academic year 2018-19.

As per reference (2) cited above the Registrar KLE University Belagavi has stated that KLE Deemed University has granted "Consent of Affiliation" to KLE Homoeopathic Medical College and Hospital, Nehru Nagar, Belagavi, to start a new B.H.M.S Degree course for the academic year 2017-18 with an intake of 100 students.

Along with the Government Order referred in Ref (3) above, the No-Objection Certification issued by the Government of Karnataka has also been forwarded to the Government of India for grant of permission. The said NOC was issued in favour of KLE Homoeopathic Medical College and Hospital, JNMC Campus, Nehru Nagar, Belagavi, to start a B.H.M.S Degree course for the academic year 2017-18 with an intake of 100 students.

As per ref (4) stated above the Government of India, Ministry of AYUSH, has granted permission to KLE University's KLE Homoeopathic Medical Collage, Belagavi to start a B.H.M.S Degree course for the academic year 2018-19 with an intake of 100 students.

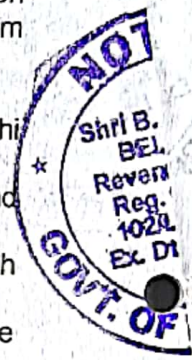

With respect to the subject cited above KLE University's - KLE Homoeopathic Medical College and Hospital, JNMC Campus, Nehru Nagar, Belagavi, is given permission to start B.H.M.S Course with an intake of 100 students, applicable from the academic year 2018-19, subject to the following terms and conditions:

1. Permission/recognition to be obtained from Government of India/ CCIM Delhi for starting the proposed B.H.M.S course.
2. Before starting the course, the institution must possess the basic facilities and sufficient staff.
3. The college must abide by the rules and regulations which are in force, with regard to allocation of government seats for admission.
4. The Institution must follow the Rules and Regulations imposed by the Government of India / CCIM.
5. To abide by the circulars, order and notifications issued by the Government of India or state government from time to time.
6. The Government shall not grant any aid or financial assistance to the said college. It is subject to permanent Un-aided conditions.
7. The institution shall not change its name or address before taking prior permission of the Government.
8. In case any of the above said conditions are violated, the permission/grant shall be withdrawn.

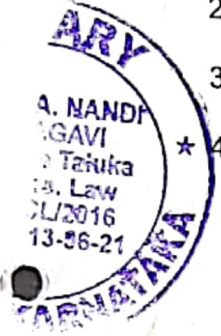

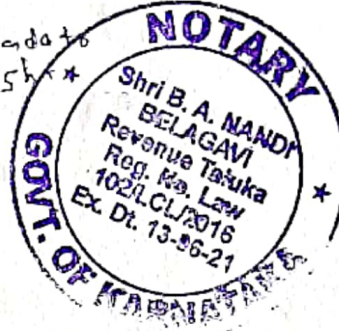
