Subject: Permission for admission in KLE University Homoeopathic Medical College and Hospital, Yellur Road, Belagavi Karnataka -590005 with 100 seats in UG (BHMS) course for the academic session 2020-21-reg.

Sir,

I am directed to refer to the provisions prescribed under Section 12C of the Homoeopathy Central Council Act, 1973 and regulations made thereunder and Ministry's policy for the academic year 2020-21, In order to verify the compliance of availability of standards by the College, the Board of Governors to CCH has examined the Part-1 of the proforma of inspection of college submitted by the KLE University Homoeopathic Medical College and Hospital and furnished the recommendation as under:

"Recommended for not allowing admission in I-BHMS Course for the session 2020-21 due to substantial shortage in teaching faculties, hospital staffs and other shortfalls."

The reasons for recommendation for not granting permission to the Applicant College and Hospital are as under:-

- 1. Details of OPD/IPD data not available in college website www.klehomoeo.edu.in.*
- 2. College has not complied with the provisions of Employee's Provident Funds & Miscellaneous Provident Act 1952 & ESI Act, 1948 and relevant Rules and Regulations as EPF/PF of teachers not deducted.*
- 3. College has provided a list of 19 teachers and one teacher not considered eligible as Dr. Swapna Anil Mahajan is MBBS, MD in Pathology with initial appointment as Lecturer, Pathology in 1/1/2018 after the age of 40 Years which is not as per MSR 2013. Moreover, promoted to Reader on 1.3.20 without completion of 4 years as lecturer.*
- 4. Only 04 GF available against the requirement of 12.*
- 5. Not a single teacher available in the department of Practice of Medicine, Community Medicine and Repertory.*
- 6. Only 07 Part time teachers of Modern Medicine available against 09.*
- 7. Required number of House Physicians (Resident) not available in hospital.*

2. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, observation of hearing committee and recommendations of the Board of Governors to CCH, **conditional permission of the Central Government is hereby granted to KLE University Homoeopathic Medical College and**

Hospital, Yellur Road, Belagavi Karnataka -590005 for continuing admissions in 1-BHMS course during the academic year 2020-21 with intake capacity of 100 seats, subject to fulfilment of all deficiencies before 31st December, 2020.

3. It is further informed that 100% of the undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as all India quota for deemed University as they are all India in nature. The counselling for seats under all India quotas shall be conducted by the Central Government. If any seats are not filled up in the Central Counselling, the same shall be transferred to the concerned Deemed University to admit students as per rules / norms decided by Central Government. The permission of the college stands withdrawn of the college fails to comply with the central counselling for all India quota or the students admitted thereunder.

4. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under HCC Act & Regulations made thereunder. Discrepancies, if any, may be immediately brought to the notice of CCH and the Central Government.

5. The College shall submit an undertaking in the form of an affidavit duly notarized within one month from the date of issue of this letter explaining the details of providing EPF and ESI facilities to the teaching, Non-teaching staff of the College/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

6. Further, the College shall submit an undertaking in the form of an Affidavit duly notarized to get permanent registration of the Teachers,/ Hospital Clinical Staff/ Consultant in concerned State Boards/ Council where the college/ hospital is located or Central Registration of CCH by 31st December, 2019 as per the decision conveyed vide CCH's letter no. 15-1/2018-CCH(3)/18510-18768, dated 16th January, 2019 and decided by the High Court of Delhi in W.P. No. 2369 of 2019, which will be verified by the Council during next visitation while considering the matter for grant of permission for the A.Y. 2021-22.

7. The College has to comply with the full requirements of HCC (MSR) Regulations, 2013 by 31st December, 2020 for continuing admissions during the subsequent year. A copy of the compliance report shall be submitted by the college to CCH under intimation to this Ministry. Subsequently, CCH shall verify the compliance well in time for considering the admissions during the Academic Year 2021-22 and furnish the recommendation to the Central Government.
