Sir,

KLE Homoeopathy Medical College and Hospital is functional since 2018 and has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 23-24, in which the entire functional profile has been narrated. The application has been examined by Medical Assessment and Rating Board for Homoeopathy as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020 and following deficiencies were noticed:

Teaching faculty:

- Professor in Dept. of Repertory is not available.
- Associate Professor in Dept. of Organon is not available.

College is required to follow standard guidelines in the functionality as under:

- Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
- Case sheets should have complete demographic details and contact details of patients.
- Diagnosis of all cases should be written in ICD 11 criteria


Considering the above observations, and facilities available, Medical Assessment and Rating Board for Homoeopathy has decided to issue conditional permission to **KLE Homoeopathy Medical College and Hospital, Yellur Road, Anand Nagar, Belagavi, Karnataka- 590005 for conducting BHMS course for the academic year 2023- 24 with intake capacity of 100 seats.** The shortfalls observed in your College shall be rectified within a period of 15 days and compliance report shall be submitted to the MARBH failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating

Board for Homoeopathy. It is further informed that 100% of undergraduate seats of the permitted intake capacity of 100 UG seats and shall be treated as All India Quota. The counselling for seats under All India Quota shall be conducted by respective counselling authority as designated by Central Government for A.Y. 2023-24. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India Quota or the students admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
